weekend for our sisters from around Florida. Our young ladies – and those young at heart – are also invited to join the Youth for Worship and we may have some of them with us Friday Evening.


A few reminders for the weekend:

## Is this for Real? A Discussion of Project 2025

Have you ever heard something so unreal that you think, this can't be true? But you stop what you are doing to fact The Department of Health and Human Services would be check? While watching the news on Hurricane Debby, I saw a social media post that said Project 2025 aimed to eliminate the National Oceanic and Atmospheric Administration (NOAA). This is the agency that tracks and predicts storms such as tornadoes, snowstorms and HURRI-CANES. I currently live in Florida where hurricanes are an annual occurrence. Previously I lived in what's known as Tornado Alley for the number of tornadoes that region experiences each year. I did a little research and found it to be true. Detailed in Project 2025 (pg. 674) are plans to dismantle NOAA and the six agencies it consists of. All these services would be dismantled, and future data collected would be required to fit the official policies of future Presidential Administrations versus setting policies based on the scientific data collected by these agencies.

I thought WOW!! Who in the world would approve of this? As I read further, I read plans to commercialize the info collected on potential storms. States would have to pay for this information. States, cities and private citizens would no longer have free access to weather predictions. We all would have to pay a company to get the weather forecasts. What on earth??

I had already been hearing various aspects of Project 2025 and how it would affect women, children, minorities, etc. So, I decided to do my own research. Below, I've touched on a few of the categories I've read and researched.

### **Federal Government**

Many of the plans written in the 2025 Mandate for Leadership (P2025) overlap in this category. There are plans to eliminate the Department of Education, eliminate National Public Radio, eliminate up to 50,000 federal employees and replace those employees with people who pledge loyalty to the specific administration in power, instead of to the United States. This includes having the heads of agencies such as the FBI, DOJ and others be charged with carrying out the President's political agenda. P2025 also plans to eliminate the federally funded preschool program for low-income children, the Head Start program.

### Marriage & Family & Faith

replaced with the Department of Life. It seems the most important aspect for much of this leadership mandate is to return the U.S. to what some refer to as the "good ole days." Throughout the document, Judeo-Christian traditions and the nuclear family are stressed. P2025 (Pg.451) stresses a traditional heterosexual marriage between a man and a woman as the ONLY acceptable family. A "family" is a married biological man, a biological woman and children. Marriage between two people of the same sex is not recognized. Marriage without children is not a family. Children without a legal marriage is frowned on. In this family, the father is the breadwinner, women who bear children are heroic and the conservative Christian church is front and center.

In the documents I read, Christianity is our implied national religion. Prayer will be brought back to schools. School choice programs will allow federal dollars to go to religious school tuition. Christian principles must be taught at home and at school. I must ask, what about our Jewish, Muslim, Hindu, Buddhist and other brothers and sisters? Will they be penalized for not being Christian? Will their children be forced to recite Christian prayers and read from the Christian Bible in schools? In Oklahoma, it was recently mandated that the Ten Commandments be hung in every classroom and that teachers teach lessons from the Bible. Non-Christians are being forced to teach the Christian Bible; does that make sense? What happened to separation of church and state? Our ELCA doctrines welcome ALL. Many of our congregations are Reconciling in Christ congregations which means we accept all who believe, no matter whom they love.

### Healthcare

The ELCA took a stand on the right of a woman to obtain an abortion at Churchwide Assembly in 1991. We state in our doctrine that abortion is a private choice between a woman, her Pastor, medical personnel and hopefully the father. Access to abortion is more than abortion-on-demand; it's part of a woman's healthcare. Under many of the laws passed since Roe Vs Wade was overturned, women have been denied healthcare after suffering miscarriages, having a fetus

die in-utero, suffering ectopic pregnancies, and suffering partial miscarriages. Women have been denied emergency services in some states because medical personnel fear being prosecuted while trying to save a woman's life. Women have died being transported to other states, bled out in parking lots or lost the ability to have more children due to lack of proper medical care. Reading through P2025, I read of; a national abortion ban; a ban on abortion drugs such as Mifepristone being mailed across state lines; a ban on stem cell research using the cells of aborted fetuses; a law making it illegal for a male, including a woman's husband or father from transporting her across a state line to obtain abortion services: and a ban on federal money to fund Planned Parenthood. Planned Parenthood provides family planning, contraceptives, teen counseling and yes, some provide abortion services. In some cases Planned Parenthood is a woman's only available option for these services. I also read of intentions to ban anyone on Medicaid or Medicare or in the Armed Forces from obtaining abortion services.

P2025 also bans healthcare using federal funds for transgender services, including counseling for LGBTQUIA+ teens. Many teens suffering identity issues need somewhere safe to turn. Teens are a very vulnerable group. Suicide is the second leading cause of death among 15–24 year-olds. According to research, LGBTQUIA+ youth are four times more likely to attempt suicide than their peers due to mistreatment and stigmatization by their peers, family and others. How will this affect the teens in our communities and in our congregations who are struggling?

### **Justice & Civil Rights**

P2025 includes a mandate to restructure the Department of Justice including requiring federal litigation to be compliant with the President's agenda, refocusing the Civil Rights Division, reinstating the federal death penalty and eliminating all existing federal consent decrees. Federal consent decrees are used by the Justice Department to ensure that businesses, industries, municipalities and agencies adhere to laws in areas of environmental law and employment and civil rights discrimination. In other words, companies and agencies that have binding agreements and performance plans to end various forms of discrimination will no longer be bound by those agreements. If one is no longer bound by a decree without achieving the stated goal, what is to prevent them from resuming the same behaviors? One police department in Florida was under a consent decree because eight Black men were shot and killed by police in less than a year. New policies were written; officers received bias and deescalation training; and goals were set. This agency completed the terms of its consent decree and is no longer in the news.

A specific P2025 mandate is to refocus and reorganize the Civil Rights Division. This will eliminate all existing LGBTQUIA+ protections and all references to Diversity, Equity and Inclusion protections in labor and government policies. DEI seems to be a "hot button" issue for many. If these programs are eliminated, how will women, people of color, legal immigrants, or the LGBTQUIA+ community be assured that we will receive equal protection and treatment? P2025 states new policies should focus on "what's good for the family." The problem is that all families are not the same. And what does this mean?

There are other "mandates" in Project 2025 that can strip away protections and rights of women, people of color, immigrants, LGBTQUIA+ and others. I encourage everyone to read about these "mandates" some want enacted. Let's learn how to protect ourselves and our sisters and brothers in Christ that P2025 will affect.

# Church Women United-World Community Day


### Most often held on the first Friday of November

World Community Day began in 1943 from discussions at a meeting of denominational presidents and executive secretaries asking that a day be set aside in the fall for the study of peace by church women. Although many denominations were printing their own studies on the new world order, it was determined at this meeting that their unity would be strengthened on one day of united study.

World Community Day continues to emphasize peace but has been broadened to include justice, a vital partner of peace. The once clear categories of "domestic" and "foreign" were consciously blurred so the global scope of the wide range of problems could be emphasized on World Community Day.
